Established in 1999, the CBA-Prince Edward Island Branch Distinguished Service Award is to honour, recognize and celebrate distinguished or exceptional service a member has made to the goals of the Canadian Bar Association. All nominations are reviewed on a basis of the individual's contribution to the Prince Edward Island Branch.

Eligibility

- The Award is open to any individual CBA member in good standing of the Prince Edward Island Branch.
- Members of the current Executive Committee are not eligible.
- Former members of the Branch Executive are not eligible for this award for a period of one (1) year from the date that their respective service on the Executive ended.

Criteria

The Award recognizes an individual who has made a great contribution to the CBA, the legal profession, or the community at large.

Presentation

The Award is presented at the CBA-Prince Edward Island Mid-Winter Meeting or some other venue determined by the Executive Committee.

Nomination Procedure:

A Nomination Form [above] must be completed and submitted by an individual.

Selection Process

The Award is administered by the Nominations Committee, a standing committee of the Prince Edward Island Executive. The Committee may determine that no Award shall be granted in any one year.
